By purchasing any of Red Lodge Mountain's Golf Pass products, the buyer agrees to the following Terms & Conditions:

A Red Lodge Mountain (RLM) Golf Pass is **NOT REFUNDABLE** and **NOT TRANSFERABLE** due to weather conditions, the Pass Holder's physical condition, injury, change of residence, or for any other reason. Pass privileges are **NOT TRANSFERABLE** (to another person and/or date) and may not be used by anyone other than the Pass Holder. In the event of a transfer to or use by another person, management of RLM may revoke the Pass and its privileges at any time without refund. This misuse is considered "Theft of Services" under Section 45-6-305, MCA, 1978, and carries a fine up to \$500 and/or imprisonment up to six months. A Couples Golf Pass is only valid if purchased by a married couple. Family Golf Passes are limited to 3 family members. Additional family members can be added to a Family Golf Pass at the defined rate. Punch Passes are only valid for the season for which they are purchased, and unused punches cannot be transferred to another season. If a Pass is lost or stolen, the Pass Holder must report it to the RLM Golf Shop immediately. A replacement Pass can be obtained for \$15.00. If a Pass is broken, damaged, or otherwise abused and fails to function, the Pass Holder must purchase a replacement Pass for \$15.00. The management of RLM reserves the right to revoke the Pass and its privileges at any time.
