RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT (“Agreement”)

For the Policy Year of 2018

In consideration of myself OR my child participating in Golf activities, and/or other activities, offered by Red Lodge Mountain and/or the Red Lodge Mountain Golf Course (“Activity”), I represent that I OR my child understand the nature of this Activity and that I am OR my child is qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge on behalf of myself OR my child that if I OR my child believe event/Activity conditions are unsafe we will immediately discontinue in the Activity.

It is fully understood that this activity involves risks of bodily injury which may be caused by my OR my child’s own actions or inactions, those of others participating in the Activity, the conditions in which the Activity takes place, or the negligence of the “releasees” named below, and that there may be other risks either not known to me OR my child, or not readily foreseeable at this time; and I OR my child fully accept and assume all such risks and all responsibility for losses, costs and damages I OR my child might incur as a result of my OR my child’s participation in the Activity.

I hereby release, discharge and covenant not to sue Red Lodge Mountain, the Red Lodge Mountain Golf Course, its respective administrators, directors, agents, officers, volunteers, and employees, any sponsors, advertisers, and, if applicable, owners and lessors of the premises on which the Activity takes place (each considered one of the “Releasees” herein), and release and discharge them from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the “releasees” or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk, that I, or anyone on my behalf OR on behalf of my child, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each of the Releasees from any loss, liability, damage, or cost which may incur as the result of such claim.

I grant Red Lodge Mountain and its respective administrators, directors, agents, officers, volunteers, and employees the right to take photographs of myself OR my child while participating in the Activity. I authorize Red Lodge Mountain to use such photographs of myself OR my child with or without my name and for any lawful purpose, including publicity, illustration, advertising, and internet content.

I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, and understand that I have given up substantial rights by signing it, and have signed it freely and without any inducement or assurance of any nature, and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law, and agree that if any portion of this agreement/release agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
